Course Level: Intermediate

Course Description: Presentation of lesson plan assignments and evaluation techniques.

End-Of-Course Outcomes: Develop and present lesson plans and the use of multi-media technology. Present evaluation techniques used in a cosmetology program. Upon completion of this course the student will:

- Develop assessment and evaluation techniques.
- Implement proper assessment and evaluation techniques.
- Judge effectiveness of assessment and evaluation tools.
